Medical Health Form Requirements Policy and Procedure

- The College specifies certain medical requirements for those students who are entering into a clinical or field placement in the Center of Community Services & Health Sciences Full-Time or Continuing Education Program.
- The medical requirements were developed by the College, to meet the requirements of our placement agency partners such as hospitals, retirement homes, medical/dental office, long-term care, school boards and other health care institutions, in order to protect the health & safety of our students and staff and the health & safety of their patients, clients and other vulnerable people against from any communicable diseases.
- The medical requirements are in accordance with the Ontario Hospital Association (OHA) and Ontario Medical Association (OMA) and Canadian Immunization Guide Pre-placement Surveillance Protocol.
- Students are required to complete all the applicable medical and non-medical requirements immediately, upon admission and registration into the program, in order to gain entry at their clinical/field placement setting.
- Students will only be granted an **EXCEPTION of NOT** getting any immunization/skin test/vaccination, if they have an allergic reaction or medical conditions. A medical note from your doctor must be submitted and attached with your health form.
- ParaMed's Occupational Health/Registered Nurses will review and assess your confidential health form documentation at your scheduled appointment. They will only stamp your health form as **CLEARED**, if you completed and met all the medical and non-medical requirements prior to the deadline. **(with exception of C116, C136 & C405 Programs)**

Measles, Mumps, Rubella (MMR)	Provide either one of the following as proof of MMR immunity: <ul style="list-style-type: none"> ➤ Documentation of receiving <u>2 doses of MMR vaccine</u> given 4 weeks apart or after 1st birthday or ➤ Laboratory evidence of immunity (blood work) 	If the laboratory evidence of immunity is indeterminate or non-reactive, A 2 nd MMR dose is required before a student can be cleared <ul style="list-style-type: none"> ➤ No further blood test required 	A medical note from your doctor must be provided in order to get an EXCEPTION : <ul style="list-style-type: none"> • Pregnant women are not able to get MMR trivalent vaccine. • Allergic reaction (e.g., generalized hives, swelling of the lips, tongue, or throat, difficulty breathing) following the first dose of MMR should not receive a second dose. • Allergic reaction to an MMR component (gelatin, anaphylactic, neomycin) should not receive this vaccine.
Varicella(Chicken Pox)	Provide either one of the following as proof of MMR immunity: <p>If the student has history of chicken pox, their health care provider must indicate the date on the health form</p> <ul style="list-style-type: none"> ➤ Documentation of receiving <u>2 vaccines</u>, given at least 4 weeks apart ➤ Laboratory evidence of immunity 	<ul style="list-style-type: none"> ➤ None 	<ul style="list-style-type: none"> ➤ People with allergies to gelatin or the antibiotic neomycin should not receive this vaccine. ➤ People with allergic reaction to a prior dose of this vaccine should not receive a second dose. ➤ Pregnant women

Tuberculosis (TB) (2-Step skin test is mandatory for First timers and w/Negative results)	<ul style="list-style-type: none"> ➤ If you are getting the TB Skin Test for the first time, it is mandatory that you receive a 2-Step Skin Test. ➤ If the result of your Step-1 skin test is NEGATIVE, you must get your Step-2 skin test within 7-21 days. In order to get accurate results. ➤ If you miss the 7-21 days period, you must redo the 2-Step skin test again. 	None	<ul style="list-style-type: none"> ➤ History of severe blistering reaction or anaphylaxis ➤ Documented active TB ➤ Extensive burns or eczema over the testing site ➤ Major viral infection ➤ Live virus vaccine in the past month
Tuberculosis (TB) w/ previous (Positive Results)	<ul style="list-style-type: none"> ➤ If your previous TB Step-1 skin test or Step-2 skin test result is POSITIVE (>10 mm) ➤ A Chest X-ray must be done and a copy of the chest X-ray report must be provided ➤ The doctor/physician must provide a medical note that the student on physical examination is CLEAR OF SIGNS & SYMPTOMS 		No annual Chest X-ray required

<p>TB Step 1-TB Skin Test is required annually for student with previous 2-Step skin test (NEGATIVE results)</p>	<ul style="list-style-type: none"> ➤ You have documented proof of having 2-Step Skin Test in the past ➤ Any returning student registering for next semester must update their Step-1 TB skin Test annually 	<p>None</p>	<ul style="list-style-type: none"> ➤ Student with previous Positive TB skin test are not required to get annual Step 1 skin test or annual chest X-ray

<p>Hepatitis B</p>	<p>Provide either one of the following as proof of immunity:</p> <ul style="list-style-type: none"> ➤ Documentation of receiving 1-3 doses of Hep B vaccine: <ul style="list-style-type: none"> • (Dose#1) • (Dose#2)-one month after dose#1 • (Dose#3)-six month after dose#1 Or ➤ Laboratory evidence of immunity (blood work) 	<ul style="list-style-type: none"> ➤ If the laboratory evidence of immunity is indeterminate or non-reactive. ➤ A 4th Dose/booster is required before they can be cleared ➤ No further blood test required 	<ul style="list-style-type: none"> ➤ A medical note must be provided in order to get an exemption for the following: ➤ A serious allergic reaction to one dose of hepatitis B vaccine should not have another dose of hepatitis B vaccine. ➤ A history of hypersensitivity to yeast should not receive this vaccine. ➤ People with a moderate or severe acute illness should postpone receiving the vaccine.

Tetanus/Diphtheria (Td) (valid every 10 years) Pertussis (Tdap)	<ul style="list-style-type: none"> ➤ Documented proof of Td immunization and it has to be given every 10 years 	<ul style="list-style-type: none"> ➤ One dose of Adacel (Tdap) should be given, if not previously given in adulthood 	
Seasonal Flu Shot/H1N1 (Recommended annually every fall/winter)	<ul style="list-style-type: none"> ➤ Documentation of receipt of influenza vaccine and it has to be done annually ➤ While not mandatory, these are strongly encouraged and required by ALL health care institutions ➤ In the event of an outbreak, any student w/o vaccination may be denied access to the facility 		<ul style="list-style-type: none"> ➤ Persons who had a serious adverse reaction to a previous dose ➤ Person with known anaphylactic hypersensitivity to eggs...manifested as: Hives, swelling of the mouth and throat and difficulty in breathing
